

**Bingo Blitz VIP Tickets for American Idol Finale Sweepstakes
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

- 1. OVERVIEW:** The Bingo Blitz VIP Tickets for American Idol Finale Sweepstakes (“Sweepstakes”) comprises three (3) drawings with entry available during three (3) separate Sweepstakes Entry Periods. **You may only enter one (1) time for a maximum of one (1) entry.** The Grand Prize is a trip to the American Idol Finale on May 18, 2025 in Los Angeles, CA. Prize details in Section 5 below.
- 2. ELIGIBILITY:** The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia, who are 21 years of age or older (“Entrant(s)”). Employees, officers and directors, and their immediate families of Playtika Santa Monica LLC. (“Sponsor”), American Broadcasting Companies, Inc., Brandmovers, Inc., d/b/a The A Team (“Administrator”), and each of their respective, parents, retailers, distributors, subsidiaries, affiliates, suppliers, advertising agencies, and persons living in the same household as such persons are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state, provincial, local laws and regulations and is void where prohibited by law. Sponsor reserves the right to verify the eligibility and all facts at any time, and Entrants agree to cooperate in any verification process/request.
- 3. SWEEPSTAKES ENTRY PERIODS:** The three (3) separate entry periods occur on the dates listed below, with entry on each of those dates available only between 7:00 p.m. ET and ending at 11:59:59 p.m. ET on the listed day (each an “Entry Period”). Any attempt to enter outside an official Entry period is void. The Administrator’s database clock is the official timekeeper for this Sweepstakes.

- 4. HOW TO ENTER:** During an official Entry Period as described above, log into your free Bingo Blitz account (“Account”) at <https://www.bingoblitz.com> (“Website”) **or** via the free Bingo Blitz mobile game app (the “App”). Once you are logged into your Account an “alert spot” will appear on the main screen. Clicking on the “alert spot” will open a registration form. Once you complete the registration form receive one (1) entry. If you do not already have an Account, follow the instructions at the Website or in the App to create your Account. **IMPORTANT:** Accessing the Website or App as a “Guest” will not provide you entry into the Sweepstakes. You must log into the Website or App using your free Account to obtain an entry. If you didn’t receive the confirmation email to create your Account, please contact rickk@playtika.com.

Any attempt to enter more than once during any Entry Period by any means, including, but not limited to, use of multiple identities, email addresses, Accounts, or other means, may result in disqualification from this and any other promotional offerings by Sponsor. Use of any macro, bot, script or other automated means to submit entries is prohibited. No responsibility is assumed for lost, late, damaged, misdirected, illegible, incomplete, incorrect entries or other sweepstakes materials, all of which are void, or for errors due to computer malfunctions, software errors, transmission problems or interruptions in

operations. All entries must be submitted and received during an official Entry Period. Proof of submission is not proof of receipt.

In the event of a dispute over the identity of an entrant, entry will be deemed submitted by the authorized account holder of the e-mail account of the e-mail address associated with the Account associated with the entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

- 5. RANDOM DRAWING AND WINNER NOTIFICATIONS:** Three (3) potential winners will be randomly selected from among all eligible entries received during each of the three (3) Entry Periods. The drawings will occur based on the chart in Section 3 above. Entrants irrevocably agree to be bound by these Official Rules, which are final and binding in all respects.

Each potential winner will be notified using the email address associated with their Account. No liability is assumed for any winner notification that is lost, intercepted or not received by a potential winner for any reason. Failure to comply when requested may result in disqualification and selection of an alternate winner. If a potential winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines a prize for any reason prior to award, such potential winner will be disqualified and an alternate winner may be selected. Any potential winner, as a condition to receiving any prize, may be required to sign and return a declaration of eligibility and liability/publicity release or similar document and complete, sign, and submit to Sponsor or Administrator an IRS Form W-9 or equivalent form with all required information within five (5) days of notification to winner of his/her prize eligibility. - 5. PRIZES AND APPROXIMATE RETAIL VALUE ("ARV"):** There will be three (3) prizes offered in this Sweepstakes, one (1) prize per Entry Period: A trip for two (2) to Los Angeles, CA. Trip will comprise round-trip coach air transportation between the major airport nearest the winner's residence and Los Angeles, CA, transportation to/from the airport in Los Angeles, two (2) consecutive night hotel accommodations (double occupancy) at a hotel determined by Sponsor, two (2) tickets to the American Idol finale taking place on May 18, 2025, transportation to/from the hotel to the filming location.

Travel must be taken on May 17, 2025 and returning on May 19, 2025. Travel dates are subject to change at Sponsor's discretion. Approximate Retail Value ("ARV") of each trip prize: \$2,400.00. Ground transportation may be substituted for air transportation at the Sponsor's sole discretion if air travel is not required due to winner's proximity to Los Angeles, CA (within 200 miles). Actual value of prize may vary depending on departure city, mode and dates of travel; any difference between announced value and actual value will not be awarded.

All travel arrangements, room selection, and other accommodations are subject to availability and Sponsor's discretion. Any upgrades or changes requested by winner are at winner's expense. Winner is solely responsible for the payment of all federal, state and local taxes and all additional meals, beverages, transportation or other expenses or costs relating to the prize not expressly set forth above. Major credit card will be required at hotel check-in to cover any incidental expenses. Winner and Guest must have all necessary photo ID, vaccination proof and/or other documents needed for air travel and

must travel on the same itinerary. Winner's Guest must be 21 years of age or older and will be required to sign a Liability/Publicity Release (where legal) prior to ticketing. Prize is non-transferable and no substitution by Winner or cash equivalent is allowed, except at the sole discretion of the Sponsor. Sponsor reserves the right to substitute prize for one of equal or greater value if the advertised prize becomes unavailable. All dates are subject to change. No responsibility is assumed for cancellation or postponement of any prize-related event or travel beyond Sponsor's control, including delays or cancellation of travel due to pandemic restrictions. Winner and/or guest are subject to removal if they engage in any inappropriate behavior on the prize trip.

Sponsor reserves the right to modify, extend, suspend, or terminate the Sweepstakes, in whole or in part, if it determines, in its sole discretion, that the Sweepstakes is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other unintended circumstances have impaired the integrity, administration, security, proper play and/or feasibility of the Sweepstakes as contemplated herein.
